

SKOKOMISH INDIAN TRIBE REQUEST FOR PROPOSAL

INTRODUCTION: The Skokomish Indian Tribe (Tribe) Has been awarded by the Indian Health Services and the Environmental Protection Agency Grant for the SKOKOMISH COMMUNITY WATER SYSTEM PRESSURE IMPROVEMENTS PROJECT. The Tribe is requesting BIDS to furnish and construct new water main extension from companies licensed to do business in the State of Washington. Project is mandated to follow Davis Bacon and Build American Buy American requirements. Bonding is also required.

PROJECT DESCRIPTION:

The project located in Mason County encompasses the construction of a new water main extension for a length of about 9,000 lineal feet. It starts at a point near the existing water well along the easterly section of N Herring Rd. From there the route is expected to go to N Pelican Rd., along Pelican Rd. to the Tacoma Power easement, then south along the power easement to Enatai Creek. The route continues south along SR 101 to a point close to Reservation Rd.

<u>SCOPE OF SERVICES</u>: The project activities will require collaborating with staff from the Skokomish Tribe Office of Community Development. The Tribe anticipates the scope of work will include the following list of activities which are not necessarily in the order of occurrence and may not be all inclusive:

- Site prep for the new water line extension
- Construction of the new water line extension
- Material and Labor for construction of the new water line extension

PROJECT SCHEDULE:

- RFP Due Date June 27, 2025, 12:00pm local time
- Notice of Selection: July 3, 2025
- Contract negotiations and contract approval: July 17, 2025
- Notice to Proceed: July 18, 2025Start Date September August 4, 2025
- Completed by November 14, 2025

The Tribe reserves the right to make the selection of the firm it deems most qualified based on the information provided in the items listed above and which is in the best interest of the Tribe. Indian Preference applies to this project. This project is federally funded, and all applicable requirements will apply as appropriate.
